a) Legal

- i. Article of Incorporation (if applicable)
- ii. Valid Tax Clearance
- iii. Valid Business Registration
- iv. Bidder should be a Registered Member of the PPCC Vendor Registry Data Base.
- v. Three Past Performance Records of Previous and Current Clients with Their Email Addresses and Telephone Numbers
- vi. Bid Securing Declaration (if applicable)

A margin of preference for eligible national suppliers shall not be applied. Additional details are provided in the Bidding Documents.

5 A complete set of bidding documents in **English** may be purchased (if applicable) by interested eligible bidders upon payment of a nonrefundable fees as stated above beginning **June 8, 2022**. The method of payment will be cash.

6 Bids must be delivered to the address below, on or before the deadline for bid submission.

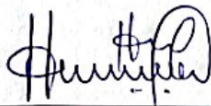

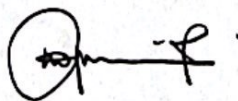
